#### **Table Top Assignment**

Space is limited and will be assigned on a first-come, first-served basis determined by time/date of receipt of contract and payment in full. ISO reserves the right of assignment and/or to relocate previously assigned space. Confirmations will be sent by e-mail directly to the designated contact.

#### **ISO Exhibitor Rules and Regulations**

- 1. CANCELLATION: All cancellations must be received in writing to the ISO office 90 days prior to date of meeting for a refund. If space is cancelled after this date, said payment will be forfeited.
- 2. ELIGIBILITY: ISO reserves the right to determine the eligibility of any company, product, promotion or part thereof, that in its opinion is not in keeping with the character and purpose of the program.
- 3. LIABILITY, INSURANCE & INDEMNIFICATION: Exhibitor is responsible for all damages to the exhibit premises and for any and all claims and demands on account of any injury or death or damage to property done in or about the premises used by the exhibitor, his employees, servants, agents, licensees or contractors occasioned by their negligence and hereby agrees to indemnify ISO and the Carlisle Banquet Center and its employees or agents, directors, officers and sponsors, against all claims, losses or damages to persons or property, and costs of defending claims arising out of or caused by an negligence on the part of the exhibitor.
